## The President

Henry Roenigk was born in Tuscaloosa, Alabama, while his father was attending the University of Alabama. The family moved to Chicago when his father attended medical school at Northwestern University. Grade school and high school were spent in Cleveland, Ohio, where his father began private practice. Henry remembers playing both offensive and defensive tackle on the football team. After high school, Henry attended Ohio University and then Northwestern University Medical School. During the summer before medical school, Henry was a head nurse on the OB ward at Cook County Hospital. Henry's first son, Randy was born just as classes were starting in medical school. When Cabrini Green opened in 1958, Henry and his wife moved into a beautiful high rise apartment there. Their second son, Ronald, was born at that time.

Henry completed an internship at Tripler Army Hospital in Honolulu, Hawaii (the Hawaii connection). He then spent 2 years in the department of dermatology at Tripler Army Hospital and the Schofeld Army Dispensary in Honolulu. It was there that his third son, Scott, was born. In 1963, Henry returned to Cleveland to begin his residency in dermatology at the Cleveland Clinic. In 1966 he was appointed to the staff of the Cleveland Clinic and served as head of the department from 1967 until 1977. In 1968 his fourth and last son, Larry, was born. During this time the Dermatologic Surgery Unit at the Clinic was begun, and dermabrasion and hair transplant procedures were performed. The head of plastic surgery at the clinic was not happy that his residents would sneak down the hall to learn hair transplant techniques from the dermatology staff. It was at the Cleveland Clinic that Dr. Roenigk became interested in Methotrexate and PUVA therapy for psoriasis and PUVA for mycosis fungoides.

In 1977 Dr. Roenigk became the Walter J. Hamlin Professor and Chairman of Dermatology at Northwestern University Medical School in Chicago, Illinois. He remained chairman at Northwestern until 1992. Henry's tenure as chairman at Northwestern was rich and full with expansion of medical and surgical facilities and faculty members. He remains a very active faculty member today at Northwestern with special interest in psoriasis, cutaneous T-cell lymphoma, and dermatologic surgery.

Dr Roenigk has written over 350 publications and 8 major textbooks. The 3rd edition of *Psoriasis*, which he co-authored with Howard Maibach, M.D. is due out in 1997. The three surgical textbooks he has written with his son Randy are especially gratifying to Henry. Henry has been an active producer of CME education : a) Hawaii Dermatology Seminars (20 years), b) Dialogues in Cosmetic Dermatology (10 years), c) 5th & 6th International Psoriasis Symposium, d) 1st & 2nd International CTCL Symposium, e) H&H Traveling Dermatology Seminars.

Randy became a dermatologist despite advice from his father to go into business. He currently heads the dermatological surgery section at the Mayo Clinic. Ronald and wife Peggy live in Chicago and run Inside Publications. Scott and his wife Amy live in Cleveland where he works for Key Bank Corporation. Larry works at Carlucci's restaurant in Chicago and at the Skin Disease Education Foundation (founded by Drs. Roenigk & Maibach). Henry has 4 grandchildren. Henry and his wife Kathie live on Lake Shore Drive (a 7-minute walk to work). Their boat in South Haven is named "Seariasis."

## NEW CHAIRMAN AT UNIVERSITY OF ILLINOIS

Virginia C. Fiedler, M.D. became Interim Head of the Department of Dermatology at the University of Illinois at Chicago on June 1, 1995. She succeeded Lawrence Solomon, M.D.

Las Vegas, Nevada was home for Dr. Fiedler until age 14, at which time her family moved to Amarillo, Texas, where she graduated from high school. Dr. Fiedler moved to the Chicago area when she entered the Honors Program in Medical Education at Northwestern University, where she received her M.D. degree. She also completed her dermatology training at Northwestern University. She is board certified in Dermatology and Dermatologic Immunology/Diagnostic and Laboratory Immunology. After completing her residency, Dr. Fiedler joined the faculty at the University of Illinois. In 1988 she joined the Upjohn Company to further pursue her research interests in hair loss disorders. In 1990 she joined the faculty at Northwestern as Professor and Director of Dermatology Clinical Research. In 1991 she rejoined the faculty at the University of Illinois as Professor and Associate Head of the Department of Dermatology and Chief of Clinical Research.

Dr. Fiedler has authored over 100 papers, abstracts and book chapters. Her chief interests are hair loss disorders: their pathomechanisms and treatments, and clinical research. She has trained several laboratory and clinical research fellows. She is currently collaborating with Dr. Raj Kumar (in her department) and Dr. Lin-fend Li (from Beijing Medical College) on a project to elucidate the molecular events occurring during induction of hair growth in alopecia areata following contact sensitization therapy.

Dr. Fiedler's greatest joy is her daughter, Kathryn, 2½, who enjoys reading stories, drawing, and playing with mommy's stethoscope.

## IN PASSING

### James J. Barrock, M. D. (1904-1995)

Dr James J. Barrock died of natural causes last year in Milwaukee. He was born to Lebanese immigrants in Chicago where his father ran a movie house and his mother sold linens door-to-door. Dr. Barrock knew in the first grade that he would be a doctor when a physician came to their home in Milwaukee to treat his mother. As Dr. Barrock looked on, the physician suggested the boy might want to become a doctor when he grew up. He graduated from Marquette Medical School in 1932, studied dermatology at the University of Pennsylvania, and set up a practice in downtown Milwaukee, where he stayed for more than 50 years, closing his office in 1990. His bow tie was his signature.

Dr. Barrock had a special place in his heart for the Chicago Dermatological Society. He always said, "This one is a gem." He loved the Society's meetings and would always come back from Chicago with some new bit of knowledge. He published several articles and made several presentations at local and international dermatology meetings. He was treasurer of the Federation of American Syrian and Lebanese Clubs for nearly 20 years and was named Man of the Year by that organization in the 1970's.

Dr. Barrock is survived by two daughters and four grandsons.

## SOCIETY RESEARCH AWARD

The Chicago Dermatological Society, through its research and education fund, will accept grant applications for clinical or laboratory research. Research must be conducted in the United States and the applicant must be a regular member of the Chicago Dermatological Society. Also eligible are residents in training and fellows, as well as Ph.D. degree-holders whose major appointment is in an academic Dermatology department. Applicants in the latter three categories who are not members of the Chicago Dermatological Society must be sponsored by a dermatology departmental or divisional preceptor who is a regular member of the Society. Only one application per person will be accepted.

The award(s) must be accepted in person by the successful applicant(s). In the event that a recipient is unable to accept the award, an alternate representative, approved in advance by the Society, must personally attend and accept it.

Limited funds are available to initiate clinical and/or laboratory research projects in dermatology. The Chicago Dermatological Society may provide up to \$10,000 in research funds for the next grant year. Applicants for grants are reviewed carefully and awarded on a competitive basis. The maximum period of funding is for one year. These awards cannot be used for payment of salary, indirect costs, or travel.

## ANNOUNCEMENTS

### Clinical Research at CMH

The Dermatology Division at Children's Memorial Hospital is looking for patients to enroll in several studies.

1. An 8 week trial of a new topical steroid in a novel base for 3-16 year olds with atopic dermatitis and at least 20% skin involvement.
2. A 12 day trial of a topical antihistamine for 6-18 year old children with atopic dermatitis.
3. A trial of the nonsteroidal topical anti-inflammatory FK506 for 3-6 year old children with moderate to severe atopic dermatitis.
4. A 14 month trial for patients aged 3 years to adult with congenital ichthyosiform erythroderma using a novel topical agent called "glylorin."
5. Patients with localized morphea or linear scleroderma for a 3 month trial of topical calcipotriene.

Future trials include a study of the topical ointment FK506 and subcutaneously administered interferon-gamma for children with moderate to severe atopic dermatitis.

### Clinical Research at Illinois

The Dermatological Clinical Research Unit at the University of Illinois at Chicago is currently conducting two clinical trials. Virginia C. Fiedler, M.D. is the principal investigator.

1. They are looking for patients ages 2-70 who have moderate to severe atopic dermatitis to enroll in a study to evaluate an injectable drug to treat atopic dermatitis.
2. They are looking for male patients ages 18-65 or female patients of non-child bearing potential ages 18-65 who have psoriasis to enroll in a study to evaluate an oral drug to treat psoriasis.

Other studies involving treatments for atopic dermatitis, earlobe keloids, and alopecia areata may be starting in the near future. ### CTCL Clinic at Rush

The Department of Dermatology at Rush-Presbyterian-St. Luke's Medical Center has begun a Cutaneous T-Cell Lymphoma (CTCL) Clinic using Extracorporeal Photopheresis (ECP). The staff is currently evaluating all types of patients in this multi-specialty clinic headed by Michael D. Tharp, M.D., Chairman of the Department of Dermatology at Rush. The clinic also includes faculty from the Radiation Oncology and the Hematology and Oncology departments. ## AAD ADVISORY BOARD SUMMARY

The Advisory Board passed by a one-vote margin at its annual meeting in February, 1996, a Resolution proposing regional elections of the AAD Board of Directors. The proposal is as follows:

- Eight districts within the U.S. and Canada drawn to represent approximately equal numbers of dermatologists.
- One individual to be elected from each district every 2 years to serve for 4 years.
- No more than one individual from any one state.
- Members wishing to run would submit a petition signed by 50 voting members within their district.
- Officers would still be elected by the entire membership.

Advisory Board members who favored this proposal felt this new governance will provide greater accountability of Board members to the membership.

This proposal is currently being evaluated by the AAD Committee on Organizational Structure, chaired by Paul Russell, M.D., and will be presented to the Advisory Board at the March, 1997, meeting for further discussion and vote. Please submit comments to your Advisory Board representative and to Dr. Russell.

**The Academy has a new computer program** to assist members in determining their capitated rate (pmpm). This RISC program is being supported by a grant from Ortho Pharmaceuticals. Call the Academy (847) 330-0230 and ask for "Socioeconomic/Practice Issues."

**A big issue that the Academy** is studying is the new HCFA proposal to change the reimbursement for the 1700 series. HCFA has proposed two codes: 1) the first code would cover 1-15 lesions, and 2) the second code would cover each additional 10 lesions above 15. This proposal is of extreme concern to the Academy.

The Academy has presented an alternative proposal to HCFA that would have the first code include one lesion. The second code would cover each additional lesion up to 15 lesions. The third code would be a stand-alone code for 15 or more lesions.

**The Academy is examining** two other important issues on reimbursement:

- 1) The proposal to prohibit separate billing of the excision of a lesion with the intermediate and complex repairs.
- 2) The request of HCFA for a comprehensive skin examination reimbursement.
